


RE-TENDER NOTICE

10. Without call deposit bids shall not be entertained.
11. Single stage one envelops will be used.
12. The Committee reserves the right to increase or decrease the quantity of tendered items as per availability of budget.
13. Photograph of each bided item shall be attached with tender. More so, if possible the bidders shall provide sample of each item along with catalogue at the time of opening of tender.
14. If no items as per specifications are available, then other item shall be selected at discretion of the Committee.
15. Interested parties may send their bids in sealed cover at following address latest by May 28th, 2022 at 01:30:pm, which will be opened in the same day at 02:00 pm in the office of the Senior Civil Judge (Admin), Shangla.
16. Successful bidder will be bound to complete supply of the items as per approved specifications within 12 days, failing which or supplying below standard items will lead to forfeiture of earnest money / call deposit and will also be liable to be proceeded against as per law and rules.
